





## What SRPS can do for you or your loved one...



Stiffler Representative Payee Services, Inc. (SRPS) is a not-forprofit social service agency. Approved by the Social Security Administration, SRPS uses Social Security and Supplemental

Security Income (SSI) to pay for the current and foreseeable needs of the beneficiaries. Funds not needed will be save for the beneficiary's future use. Monitored and audited by the Social Security Administration (SSA), Stiffler Representative Payee Services, Inc. provides payee services to adults and children who have been determined by SSA to be disabled and/or have a drug addiction or alcohol condition; the homeless population and the mentally ill.


As a Fee for Service Organizational Representative Payee, we will work with the beneficiary, targeted case manager and providers to determine the beneficiary's current needs for day-to-day living (food, clothing and housing) and use his or her payments to meet those needs.

Stiffler Representative Payee Services saves any money left over after meeting the beneficiary's needs in an appropriate account; keep written records of all payments, and bank statements. Receipts are kept to show how money was spent. SRPS also provides monthly and/or annual accountings for the use of funds. SRPS will be aware of income, funds, and items a beneficiary may own that can be converted to cash and/or resources that may impact the beneficiary's payments or eligibility; report changes or events that could affect the beneficiary's payments or eligibility; and return conserved funds to SSA if Stiffler Representative Payee Services, Inc. stops serving as the beneficiary's payee or if the beneficiary dies.

Stiffler Representative Payee Services will also go beyond managing finances and be actively involved in the beneficiary's life by establishing a budget and involving him or her as much as possible in the decision-making process; explaining Social Security and/or SSI payments and expenses to him or her, assisting the beneficiary in completion of redetermination of eligibility and continuing medical reviews; and working cooperatively with caseworkers to help individuals obtain other benefits such as food stamps and housing benefits.

Stiffler Representative Payee Services, Inc. establishes an accounting system for each beneficiary that tracks how much money was received; how much

was spent; and the balance saved for each beneficiary. Stiffler Representative Payee Ser-



Monthly and annual reports will be sent to guardians as needed for annual accountings to the courts.
